#### Introduction

MC 221 is the second semester of a year-long introduction to the study of international relations. It builds upon the concepts, theories, and actors covered in MC 220, and applies them to the international political economy and globalization. The central theme of this course is to understand conditions under which transboundary economic flows are blocked or enabled by governments.

The semester begins by revisiting theories of international relations studied in MC 220. We will use these approaches to develop expectations about how domestic and international politics influence economic behavior. We will then test these expectations by exploring how states regulate transboundary flows of products, people, information, and money. In the final part of the course, we will focus on how these transboundary movements – and their regulation – impact pressing contemporary issues such as economic development, criminal justice, environmental protection, and disease control.

#### **Learning Objectives**

By the end of this course, you will:

- Appreciate how international relations theories explain key events in the global economy
- Recognize how you personally interact with the global political economy
- Assess structure, power and influence of institutions underpinning the contemporary global economy
- Become familiar with relevant stakeholders, their preferences, and the path by which they (or you) can influence international relations
- Understand how economic flows influence and respond to domestic and international politics
- Strengthen international relations research skills

# **Course Meetings**

We will meet twice every week. Class will focus on discussion of the readings for that week, and their application to current events. This class is designed to enhance your verbal, as well as written, communication skills. It is essential that all class members contribute to the conversation so that we can learn from different points of view. You are expected to prepare, attend, and participate every time we meet. Please contact me in advance if you must miss a class session.

We will have animated discussions about many controversial topics. You should be prepared to support your position <u>with evidence</u>, and are encouraged to disagree with me and with each other, but **you must pay attention to, and be respectful towards, each other's views and experiences**.

Finally, although laptops and other devices may be useful at times, they can also distract you and others sitting around you. Recent research shows that handwritten class notes may be more effective (see "Take Notes by Hand for Better Long-Term Comprehension," <a href="http://www.psychologicalscience.org/news/releases/take-notes-by-hand-for-better-long-term-comprehension.html">http://www.psychologicalscience.org/news/releases/take-notes-by-hand-for-better-long-term-comprehension.html</a>). You may must now use laptops and other electronic devices during class, but please use them for class-related purposes only. All written assignments — except reading notes — must be submitted <u>on paper</u>. You are strongly encouraged to discuss all projects with Professor Axelrod during office hours.

You will receive a grade for each day of class and each assignment on the 4.0 scale. At the end of the semester, those grades will be weighted and averaged as indicated above. Weighted averages of greater than 3.75 will result in a 4.0 reported grade for the semester; 3.25-3.75 = 3.5 reported grade; 2.75-3.25 = 3.0 reported grade; 2.25-2.75=2.5 reported grade; 1.75-2.25=2.0 reported grade; and so forth.

For all assignments, late papers (unless accompanied by doctor's note or other verified excuse) will receive a reduction of one grade point for every two days after the deadline (i.e., 1 minute to 48 hours late reduces grade by 1.0; 48-96 hours late reduces grade by 2.0). I do recognize that difficulties arise outside of the course, and I will therefore allow a single "life happened" extension on one written assignment (short essay, research question, OR final proposal). If something happens and you need an extension, you may use this option for a three-day extension, no questions asked. Please email me before the deadline so I know you are using the extension. However, you can only use this option once during the semester, so plan accordingly. The "life happened" extension may not be used to reschedule exams.

Similarly, you may use <u>one</u> free absence from class with no questions asked and no grade impact. For all other excused absences, please discuss with me ahead of time and provide a reason for your need to miss the session.

### **Course Readings**

Please note that you should not accept course readings at face value. I have not chosen them because I agree with everything written, nor do I expect that you agree with their conclusions. You should know the authors' arguments, but you are expected to read critically. I think these materials represent good entry points into the topics that we will study, and they generally do a good job of identifying the interesting issues related to those topics. However, you should approach readings (and statements in class) with a healthy degree of skepticism. When you confront an argument, I hope you will start by asking what evidence is available to support that argument. Following an analytical approach will help you gain a better understanding of the subject, and will make you a better student and scholar as well.

Relatedly, please make sure evidence is drawn from reputable sources that have an incentive to provide accurate information. For suggestions on identifying valid news sources, in particular, see Professor Melissa Zimdars' guidelines (https://docs.google.com/document/d/10eA5-mCZLSS4MQY5QGb5ewC3VAL6pLkT53V 81ZyitM/edit).

<u>You are expected to read all assigned materials before the session noted in this syllabus.</u> As in all Madison College courses, I realize that there is a significant amount of reading assigned. This load is necessary to grasp broad theories of international political economy, while also applying them to real life situations. Class discussion will center around the assigned reading materials, particularly those drawn from news sources. As a result, you will need to be familiar with these events and ideas before coming to class, and you are also strongly encouraged to bring all materials with you for reference. I will often email reading questions in advance to help guide your preparation for class.

- 2) As you will note, many of the readings are drawn from journals, magazines, or newspapers. These readings are equally, if not more, important for our class discussions. The D2L version of this syllabus contains hyperlinks to all news articles [NY Times articles, beyond the monthly allotment, are also available free online through the MSU Library]. Other materials are available online or through the MSU library website (www.lib.msu.edu), as noted [search by article title in the search box].
- 3) In addition, you are expected to keep track of news related to international relations and the global economy. *The New York Times* (available online at a discounted student rate) has excellent reporting on these topics, and you are expected to be aware of current events reported there. However, it is important to see other perspectives as well, so I encourage you to also look at other US and foreign news resources available online. For example, *The Financial Times* also provides good coverage of international economic issues, particularly those related to the European Union, and *The Guardian* is known for its coverage of economic development from a European perspective. One particularly good source for a developing country perspective in English is *The Hindu* (www.thehindu.com), published in Southern India. In addition to newspapers, I recommend *Economic and Political Weekly* (www.epw.in) for more in-depth analysis of developing country concerns. Many articles from these publications are listed in the syllabus, and these reports are part of your required class readings. You are expected to read them before, and be prepared to discuss them in, class.
- 4) Finally, I will of course be happy to recommend supplementary readings on topics that interest you, or on which you are conducting research.
